### **SAHPA Foreign Temporary Membership**

Welcome to South Africa. We wish you a wonderful stay and safe flying.

*It is a legal requirement that a visiting pilot has to have a SAHPA temporary membership. Flying without the SAHPA temporary membership is illegal, and could impact on insurances held by the pilot. The membership is valid for 2 months. It is important that you contact the local club members or instructors in the area you will be visiting so that you can be briefed on the conditions, site rules, etc. You'll find a complete list of all South African clubs and schools on the SAHPA website along with their contact details.*

### **Radio Licence**

*To use the designated frequencies in South Africa, one must have a licence, which SAHPA is empowered to issue and is included in this licence. An air band radio licence is required for PPG / PPT / PPC and is not included in this licence. Contact a designated examiner for this Part 62 air band restricted radio course. You'll find their contact details on our website.*

### **Third party and site insurance**

*Although it is acknowledged that most pilots have valid third party insurance from their country of origin, it does not cover visiting pilots pertaining to site insurance locally. It is required that this local third party insurance be paid up. It is a group insurance and is covered by this fee.*

### **To apply**
